a) Short listing Process

The applications will go through the process of screening for the eligibility of the candidates. The shortlisted candidates will be invited to appear before the selection committee for the personal interview.

b) Selection Process

The candidates are expected to make a short oral presentation with or without ppt. They will face the interview panel as a part of the selection process.

6. Program Duration The program duration will extend over 11 months. The commencement date will be in September 2021.

15. What are the projects I need to take up?

- b) One Major Project A detailed study will be designed and executed by the participants under the guidance of the institute mentor in the healthcare organisation of their choice. The participants will submit the study proposal for approval before the conducting of the study. The report on the findings of the study will be evaluated for the award of certificate.
- **16. What is the mode of program delivery?** A hybrid model is adopted for the conducting of the sessions. Technology will be selectively harnessed as an enabler for self-directed exposure and self-paced learning. The program will be conducted both virtual and in-campus.
- **17. How will the on campus sessions be conducted?** The program involves four incampus classroom faculty-participants interactive learning sessions. Each session will be for 10 days that will be spread across the entire duration of eleven-months of the program.
